Statewide Conference Call Summaries from Friday, April 3, 2020

Following the CMS (federal) site visits, CMS is reporting back that Florida has some issues to work on with proper PPE and use in the healthcare setting

From the State Surgeon General Rivkees

- All hospitals MUST develop surge plans.
- All hospitals must report surge information to the Healthcare Coalition Coordinator by COB today. (Region 3 HCC has developed a ReadyOp survey and provided it to hospitals)
- Guidelines related to pediatric and newborn care was released and sent to those professionals
- All facilities MUST use strict adherence to PPE policies

From AHCA Secretary Mary Mayhew

- COVID response is very complex and requires taking a multi-faceted approach
- ESS has allowed Florida to have a level of real-time data on hospital and sub-acute care beds across the state. The system continues to be expanded to better understand bed usage
- Now asking for information about number of ventilators
- Also asked to identify and report the number of anesthesia machines that can be converted to ventilators
- ESS data MUST be reviewed regularly and updated twice daily. Even if data does not change, the system reverts entries to zero at the end of the reporting period. All data must be updated every time
- AHCA is working with LTC, SNF, ALFs to support effective and appropriate decisions making concerning discharge from hospitals to sub-acute setting. This is a shift in normal processes. Facilities must consider ability of receiving facility to appropriately provide infection control standards
- Governor Desantis has taken a firm stance, by EO, on the cancellation of elective procedures. It is critical that this is followed to conserve capacity and PPE
- CMS released recommendations last night- 1. Identify potential regional capacity to designate a wing or other facility to serve as isolation and recovery unit for COVID positive patients that require step-down care, but cannot go back to sub-acute setting
- Discharge Planning – focused on elderly. Important that elderly is not returned to sub-acute setting in facilities to potentially infect others. Must have strong infection prevention and control.
- Recommends healthcare facilities has a PPE spotter who can watch people don and doff to assure levels of protection.
- We must strengthen our resolve to maintain social distancing and reduce large gatherings

FHCA Updates

- ESS system must be updated by 10am daily deadline. Data goes back to zero at the end of each day, so please update daily, even if your numbers don't change
- Audit your advanced directives for patients
- Guidance from FDOH "Return to Work for Essential Personnel" has been updated and included on the FHCA website
