#### **Expenditure Requests**

#### Management and Administration Update

- New Staff Addition: Monica Dominquez is joining the Regional Council to implement programs that support the Healthcare Coalition. She will be working on the North Florida Resiliency Plan for the Health and Medical Lifeline.
- National Healthcare Coalition Preparedness Conference: The conference is still taking place in Orlando in December. Two additional members will be attending, making a total of six using scholarship funds provided by the Coalition.
- 2021-2022 Project Funding Update: All projects are in process. One project recipient has already requested reimbursement. All projects are o target to be completed by the January 31 deadline.
- **Resuming In-person meetings:** Board members discussed resuming the in-person meeting options in January. Dave Chapman, St. Vincent's Southside reported that the meeting room is reserved and available for group meetings.
- **BinaxNOW COVID Testing Kits:** FDOH has offered the testing kits to Healthcare Coalition members at no charge. These kits expired 9/30/21 and are under a shelf-life extension until 12/30/21. Each box contains 40 tests and retail for approximately \$499.00. To date, the HCC has ordered 800 boxes of tests kits for members.

#### **BUSINESS**

#### \*Approval of General Membership Requests

As required in the bylaws, the Board must approve all membership requests. There have been six (6) membership requests since the last meeting. The list was provided in the meeting packet.

#### Board Vacancy for Emergency Management

Staff reported that there is a vacancy in the Emergency Management discipline. Greg Foster (Nassau) retired and Percy Golden (Duval) has moved to a new position within JFRD. The regional Emergency Managers will meet in December and staff will request that select a new representative and alternate.

#### TRAINING AND EXERCISES

#### MRSE Exercise

Staff reported that the required Coalition Surge Test (CST) Exercise is now called the Medical Response and Surge Exercise (MRSE). The Alliance will hold this exercise on March 9, 2022. Hospitals will be contacted about participating

#### FIDTN Exercise

Staff reported that The Alliance will participate in the Stateside Florida Infectious Disease Transportation Network, FIDTN, Exercise on February 22, 2022. The FIDTN is that State's plan to transport a highly infectious (e.g. Ebola) patient using a 'daisy chain' approach across Florida and then transfer the patient to Georgia EMS for final transport to the Region Treatment Center at Emory. Alachua County EMS will participate in this exercise for the Region.
