Management and Administration Update

• New Staff Addition: Monica Dominquez is joining the Regional Council to implement programs that support the Healthcare Coalition. She will be working on the North Florida Resiliency Plan for the Health and Medical Lifeline.

Infectious Disease Pilot Projects:

- EMist Sprayers for Long-Term Care: The Coalition purchased 35 units for distribution across the 18-county region. 15 units have been sent to facilities in the 6 counties of the Northeast Florida Coalition. 5 units are still available to members. Please reach out to staff if you are interested in one of the remaining units.
- EMist Sprayers for EMS Partners: The Coalition is working with our EMS discipline representatives on the potential use of the EMist sprayers in EMS transport vehicles. This can be a low-cost solution to increase infectious disease prevention, particularly for those counties that do not have an Aeroclave unit.
- Ventilated Headboards: Coalition staff is working with a facility in our sister healthcare coalition on the use of a ventilated headboard. In addition to providing increased protection for staff ventilated headboard can also significantly reduce the amount of time required to purge the room of potential contaminants within the air. The use of ventilated headboards can eliminate the need to let the room sit after discharge of a COVID-19 patient prior to performing terminal cleaning to prepare the room for admission of another patient.

Details are being gathered on the purchase, setup, and use of the headboard to determine if this could be a useful infectious disease prevention resource in other healthcare settings. Staff will revisit this pilot program as more information becomes available.

National Healthcare Coalition Preparedness Conference: The conference is still taking
place in Orlando in December. Four members will be attending using scholarship funds
provided by the Coalition.



CST vs MRSE Exercise

Staff discussed the sunset of the Coalition Surge Test (CST) exercise. The CST exercise is being replaced by the Medical Response and Surge Exercise (MRSE) exercise. Staff will provide an overview of the new MRSE exercise once it has been released by ASPR.

Florida Infectious Disease Transportation Network (FIDTN) Exercise

The North Central Florida Health Care Coalition will be implementing the FIDTN Exercise on February 22, 2022, in Alachua County. The planning team has asked the Northeast Florida Healthcare is they can provide subject matter experts to assist as exercise controllers or evaluators. Staff will reach out to our membership to address exercise needs once they have been formally determined.

OPEN DISCUSSION

- EMS Paramedicine major topics of discussion. The EMS discipline is also looking at the use of drones in the deployment of EMS personal and response resources. They have estimated a substantial cost savings using drones versus traditional transportation methods of a helicopter.
- Public Health The Governor has announced a new State Surgeon General. Additionally, FDOH County offices are beginning to turn the corner on the COVID-19 activation. Some of their normal processes are beginning to return as the numbers begin to reduce across the region.
