Management and Administration

EMAG 2023

18 individuals expressed interest and approval by their agency/organization to go to EMAG 2023. All individuals have been registered for the conference and have hotel reservations. 2022-2023 Project Funding Update

Alliance Radiation Surge Annex

Staff thank all members who provided feedback and review of the Alliance Radiation Surge Annex. After review of the comments and suggestions, staff have updated the Annex and will upload the finalized version to the Alliance website.

2023 Alliance Operational Plan

Staff report they have made updates to the 2023 Alliance Operational Plan, as part of the contract deliverables. The updated Operational Plan was disseminated to the membership, and review/feedback was provided to staff. The finalized 2023 Alliance Operational Plan will be uploaded to the Alliance website.

HVA Gaps Project

The Alliance Board has identified pre-hospital pediatric surge management to be a prioritized, regional gap. The State has approved the Coalition's request to use the additional HVA gap

funding to purchase equipment to help fill this regional gap.

*Staff remind the Board members and discipline representatives for the upcoming election. Board officers are elected, and discipline representatives are approved by the respective disciplines governing body. There will be a call for nominations during the April meeting, and voting will take place during the May meeting.

TRAINING AND EXERCISE

Virtual TTX Offerings

Two offerings of an active threat virtual tabletop exercise will be provided through the Coalition on May 8th and May 16th. Both offerings will be from 1:00 to 4:30 PM. The flyer and registration information will be distributed to the Alliance membership soon.

Statewide Radiation Surge Tabletop Exercise

In partnership with the State and the HCCs across the state, there will be a virtual, tabletop exercise on May 17th from 9:00 AM to 1:00 PM, to test the new Alliance Radiation Surge Annex. This statewide exercise will provide the opportunity for regional breakout groups for each region to talk about their threats, capabilities, and gaps. There will be statewide report-outs, to see how different regions would respond, following the regional breakout. The flyer and registration information will be distributed to the Alliance membership soon.

Overland Flooding TTX – St. Johns County

The Coalition is providing a fifth offering of the overland flooding tabletop exercise, previously offered last winter, at the St. Johns County EOC on March 30th, from 1:00 PM to 4:00 PM. This TTX can assist organizations in complying with CMS rules regarding exercise participation. The flyer will be attached to the meeting minutes packet. PER-320 Course

Staff report they have finalized with TEEX the dates and registration links for this course delivery. It is a full-day, in-person training. Individuals who attend this will train on PPE, with donning and doffing and other considerations during a biological event. Supply chain issues are not as bad as they used to be, reports about every week there is an issue with one individual supply.

Public Health

 Regional FDOH – Ms. Vaughn reports the highly infectious disease response kits will be housed at the Jacksonville warehouse. If this is ever needed, the kits can be requested through your local county health department or Freda Vaughn directly. Following the February CHEMPACK sustainment visit, all supplies that were expired were re-supplied.

- Long-Term Care Nothing to report.
- EMS Mr. Tim Devin reports the EMS community continues to discuss the pre-hospital pediatric gaps in the region. They continue to engage with key players on this issue to start closing this equipment gap.
- Emergency Management Mr. John Blanchard from Baker County reports they participated in Nassau County's full-scale exercise with CSX. States it was helpful, and multiple people from across the region were in attendance. Reports all training continues to be on schedule.
- Home Health Nothing to report.
- NAS Jacksonville Hospital Ms. Kaitlen Doyle introduced herself to the Board, as she is the EMO for the Jacksonville Naval hospital. Reports they are working on re-standing up the FROT and are currently working closely with the Army Civil Support Team at Blanding.

CMS Provider/Supplier Tabletop Exercise Overland Flooding

This exercise will be a comprehensive discussion-based tabletop exercise with an open discussion led by exercise facilitators.

Participants will have an opportunity to evaluate their current response concepts, plans, and capabilities related to a flood scenario. This exercise will focus on providing a scenario that should stimulate participants to reflect on their own organizations' capabilities and identify local risks and hazards.

Participating organizations will walk away having identified strengths and areas for improvement within their Emergency Plan. The exercise facilitators will provide participants with an After-Action Report (AAR) overview and document template that can be completed by individual facilities.

Personal Protective Measures for Biological Events PER-320

Personal Protective Measures for Biological Events (PPMB) is a one-day course focusing on the challenges faced by first responders and clinical health care professionals in pre-hospital and hospital environments as they deal with personal protective equipment (PPE) needs and potential contamination issues while dealing with highly infectious diseases. The course provides students with an overview of PPE, and includes experiential learning activities on donning and doffing PPE and technical decontamination. Additionally, students review the different types of decontamination.

FEMA SID Guide

FEMA Student Identification (SID)

What is a FEMA SID?

FEMA Student Identification (SID) number is a unique number generated and assigned to anyone who needs or is required to take training provided by a FEMA organization. Your FEMA SID uniquely identifies you throughout the FEMA organization and all of its agencies. The goal is for your FEMA SID to serve as your personal identification number instead of your Social Security Number (SSN) in support of FEMA's effort to decrease/cease the use of SSN for identifying and tracking individuals.

Why do I need a FEMA SID?

A FEMA SID is required to register for and participate in any training provided by FEMA. All FEMA training providers' registration systems and enrollment procedures require a valid FEMA SID. The FEMA SID will serve as your unique identifier and be used to maintain the record of FEMA training you attended.

Do you have a FEMA Student Identification (SID) Number?

To register, go to the <u>FEMA Student Identification System</u>
Select "Register for a FEMA SID" in the middle of the screen. Follow the instructions and provide the necessary information to create your account. If you are a user with a Personal Identity Verification (PIV) card, enter your FEMA SID and select your certificate and enter your pin.

Forgot your FEMA SID?

If you already have a FEMA SID but forgot it, go to the <u>FEMA Student</u>
<u>Identification System</u> and select the option: "Forgot Your FEMA SID." You will be asked to provide certain information. Your FEMA SID will be emailed to you along with a separate message that will ask you to reset your password.
